- a. Out of courtesy, when Presbytery is debating, all remarks shall be addressed to the moderator and shall be made from the floor.
- b. In the interest of time and to allow as many as possible to speak, speeches will be strictly limited to 2 minutes. Persons wishing to speak should move to the appropriate microphone. So there is clarity, a speaker should begin by saying, "I speak for (or against) the amendment..."The moderator will rotate between calling on a person in favor, and then a person opposed, etc.
- c. Remarks shall be confined to the pending question. The moderator will interrupt if in his/her judgment the speaker has drifted from the pending question.
- d. Commissioners may not refer adversely to prior acts of Presbytery not pending now.
- e. Remarks shall not impugn another commissioner or that person's motives.
- f. Distribution of reports or documents shall not be done during the meeting.
- g. Commissioners shall not disturb the meeting, by applause or verbal response to remarks made by a commissioner, or in response to a vote.

The Presbytery **APPROVED** the February 2021 stated meeting minutes. Approval of the February 2021 minutes were considered at this annual meeting since the June 2021 stated meeting was not held due to the COVID-19 pandemic and other considerations.

X. GREETINGS FROM THE PRESBYTERIAN HISTORICAL SOCIETY

David Staniunas brought greetings from the Presbyterian Historical Society. David shared the mission of PHS and described the services PHS can provide to churches to help preserve their records. Marsha Heimann, also representing PHS, shared the importance of maintaining the archives.

XI. COMMISSIONING OF YOUNG ADULT VOLUNTEERS

Presbytery welcomed this year's class of Albuquerque Young Adult Volunteers. The three YAVs (Peter Compton, Savannah Gold, and Emma Yoder) were introduced and then were commissioned by Luke Rembold, YAV Coordinator, and Moderator Westmoreland.

XII. REPORT FROM THE YOUTH/YAV COORDINATOR

An annual report on the youth and YAV programs was received by the Presbytery as part of the consent agenda. Luke Rembold reminded the Presbytery that we will be sending a delegation to Youth Triennium in July 2022.

XIII. STATED CLERK REPORT

Stated Clerk, Stephen Rhoades, gave the Stated Clerk report. Several items on the Stated Clerk Report were approved or received as part of the consent agenda earlier in the meeting.

The Presbytery **APPROVED** the proposed revision to the By-Laws. The revision adds a list of New Mexico counties to the description of the Presbytery's territory.

ARTICLE III

Territory

The territory in which the Corporation's operations are principally to be conducted is the territory shown within its geographical boundaries on Exhibit "A", which is attached to and made a part of these Bylaws.

The territory includes the New Mexico counties of Bernalillo, Catron, Cibola, Colfax, Harding, Los Alamos, McKinley, Mora, Rio Arriba, San Juan, San Miguel, Sandoval, Santa Fe, Sierra, Taos, Torrance, Union, Valencia, and most of Socorro county including Socorro and Magdalena.

Stated Clerk Rhoades presented a first reading of proposed revisions to the Standing Rules. The revisions allow for electronic meeting and voting, as well as changes to align the Standing Rules with the By-Laws. The proposed revisions will be voted on at the February 2022 meeting.

Stated Clerk Rhoades reported that the disciplinary case toward Rev. Lorelei Kay has been completed. The terms of the supervised rehabilitation have been satisfied and the Permanent Judicial Commission has received and approved the final report from the supervisory team. Moderator Westmoreland led the Presbytery in prayer for those involved in resolving the disciplinary case.

The Presbytery **APPROVED** the Stated Clerk's recommendation that Albuquerque Immanuel, Albuquerque La Mesa, Albuquerque Sandia, Albuquerque Second, Rio Rancho, and Taos First be allowed an additional commissioner for 2022. The current membership numbers of these churches reduces their commissioners according to the Standing Rules. The recommendation allows the churches to maintain their current number of commissioners to Presbytery and attempts to equalize the balance between attendance of Ministers of Word and Sacrament and Ruling Elder Commissioners at future meetings.

XIV. ADMINISTRATIVE COMMISSION FOR GALLUP, WESTMINSTER REPORT

MWS Lou Knowles reported that the commission is working with the members of the congregation to consider next steps for pastoral leadership.

XV. CAMINO DE VIDA TASK FORCE REPORT

MWS Jeff Finch shared a review of the work of the Task Force since it began in October 2019. The Task Force has completed its charge by determining that Camino de Vida should remain a new church development at this time.

Presbytery **APPROVED** to dismiss the Task Force with thanks.

MWS Seth Finch presented the motion that the Presbytery create an Administrative and Advocacy Commission to Camino de Vida with the purpose of providing a supervising entity in conjunction with the Evangelical Lutheran Church of America.

Presbytery **APPROVED** to authorize and charge an Administrative and Advocacy Commission to Camino de Vida.

Motion to authorize and charge to an Administrative Commission

1. An Administrative Commission be created, in this instance being termed and Administrative and Advocacy Commission (AAC) consisting of 3-5 people from the Presbytery of Santa Fe. As outlined in the Presbytery's Standing Rules, members will serve in rotating classes of 3 years, with a maximum service of 6 consecutive years.
2. The AAC's purpose is to be the administrative and advocacy connection for Camino de Vida and its missional pastor to the Presbytery. The AAC will interface primarily through the Commission on Ministry (COM), though also collaborate with the Mission Networking Committee, as appropriate. Matters regarding funding of Camino de Vida and its missional pastor will be coordinated with the Finance and Property Commission (F&P). Sabbatical arrangements will be coordinated with COM.
3. Camino de Vida, a non-chartered fellowship under the auspices of the Rocky Mountain Synod of the ELCA and the Presbytery of Santa Fe, has its own Steering Committee (Comité Directivo). However, as a type of New Church Development, Camino de Vida's Steering Committee is not vested with the authority normally assigned to a Session. The AAC for Camino de Vida, for the foreseeable future, therefore will assume Session-related responsibilities where such capacity benefits Camino de Vida and its missional pastor.
4. The AAC will have the ability to act on behalf of the Presbytery in ecumenical matters relating to the ELCA, including activities and function of the ministry, training and development.
5. The AAC is charged with proposing adjustments to the missional pastor's salary, overseeing the budget of Camino de Vida, and proposing sabbaticals for the missional pastor, in concert with F&P and COM, and bringing those initiatives to fruition. Substantive actions of the AAC will be reported at the subsequent meeting of the Presbytery.

Moderator Westmoreland has appointed MWS Jeff Finch, RE Bryan Beck, RE Anita Torres, and RE Ester Griego to serve on the AAC.

XVI. FINANCE AND PROPERTY COMMISSION REPORT

RE Kathy Rhoades presented the 2022 budget.

Presbytery **APPROVED** the 2022 budget as presented.

Kathy reminded the Presbytery that in 2018 it approved a recommendation to set aside 3% of the income from investments to be spent on special projects. Although the funds have been set aside, they have not been spent. The Commission presented Spending Policy Disbursement Proposal.

Presbytery **APPROVED** the Finance and Property Spending Policy Disbursement Proposal.

Finance and Property Spending Policy Disbursement Proposal

This proposal is to determine the method of disbursing from this account for special projects and other initiatives of the Presbytery.

An ad hoc committee made up of 6 persons (one from COM, one from CPM, one from F & P, the moderator or moderator elect, and two at large members (one Minister of the Word and Sacrament and one Ruling Elder) would meet to determine how best to use these resources. Each committee appoints their representative and the moderator appoints the two at large members.

The charge of this ad hoc committee would be to receive, consider and recommend funding requests, and bring them to Finance and Property Commission for final consideration.

These projects could be multi year projects, however each individual calendar year should not exceed \$40,000. No funding is currently available for any projects expected to last longer than three years.

Presbytery **RECEIVED** the report of the Finance and Property Commission as part of the consent agenda.

Finance and Property Commission Report

F&P held meetings on June 25 and August 23, 2021.

Actions Taken On Behalf of Presbytery:

- Approved a request from First Presbyterian Church, Raton to sell the property on 6th Street.
- Approved a request from First Presbyterian Socorro to sell unused land.

For Information:

- Finance and Property has reviewed the detail financials with Financial Assistant, Chad Poole and reviewed the investment portfolio with the financial advisor.
- F&P has reviewed the Presbytery's insurance policies and adjusted the property coverage at the Camino de Vida property. The Church Mutual umbrella policy of the Presbytery and associated churches will continue, and the full cost of the policy will be included in the annual budget.
- The commission recommends that churches in the Presbytery of Santa Fe have an insurance policy of at least \$1 million and \$3 million aggregate, include officers/directors/trustee protection of at least \$500,000, include sexual misconduct liability, and include additional protection for childcare. The commission also recommends that all churches have an additional umbrella policy.
- F&P decided that Per Capita will remain the same for 2022, \$35 per person.

Treasurer Bill Belvin reviewed the financial reports showing the Presbytery's financial status as of September 30th.

XVII. COMMISSION ON PREPARATION FOR MINISTRY

MWS David Whiteley informed the Presbytery that Christin Moreland has been examined and approved for candidacy status by CPM. Christin Moreland shared her recent faith journey and ministry experiences while in seminary.

David informed the Presbytery that CPM is reviewing and revising the process for commissioned ruling elders.

Presbytery **RECEIVED** the report of the Commission on Preparation for Ministry as part of the consent agenda.

Commission on Preparation for Ministry Report October 16, 2021

CPM has met online monthly, except in July, throughout 2021.

Actions on behalf of Presbytery:

- 1) CPM APPROVED to move Christin Moreland to the candidacy phase.

Other Actions:

- 1) CPM met with potential CRE inquirer Frank Shope, member at Sandia Presbyterian and former minister ordained by Southern Baptist conference, and made recommendations to begin the process.
- 2) CPM completed an annual consultation with Daniel Williams and approved Daniel to continue as a candidate. CPM is pursuing alternative means for Daniel to fulfill the requirement of clinical pastoral education.
- 3) CPM requests the transfer of inquirer Edward Lewis from Grace Presbytery to Santa Fe Presbytery.
- 4) CPM is considering changes to the process for commissioned ruling elders and commissioning elders to serve in specific capacities in the church are receiving the specified training.

XVII. GATHERING IN NETWORKING GROUPS

The report from the Mission Networking Coordinators was moved to the afternoon due to the meeting running behind.

Participants gathered in groups of interest between Mission Networking, Education Networking, and Worship Networking to discuss the current work of the Coordinators and possible plans for future networking.

Presbytery recessed for lunch at 12:25 pm.

At 1:10 pm, time was given for announcements to be shared.

The meeting reconvened with prayer led by Moderator-Elect Clara Storms at 1:20 pm. The moderator-elect moderated the remainder of the meeting.

XIX. MISSION NETWORKING COORDINATORS REPORT

MWS Roger Scott Powers shared that the Family-to-Family fund has helped 99 families since April 2020.

RE Conrad Rocha, Stated Clerk for Synod of the Southwest, and RE Nelson Capitan thanked the Presbytery and the churches for supporting the Synod’s Native American COVID Relief program. They shared a presentation of the food boxes that were packed and delivered to Native American families.

XX. COMMITTEE ON REPRESENTATION AND PARTICIPATION REPORT

MWS Ginna Bairby presented the nominees to serve in positions of the Presbytery. She added the nomination of RE Sharon Kirby to serve in the Class of 2022 on Commission on Ministry.

1. At its March meeting, CT APPROVED that the June Presbytery meeting will be virtual only. At its May meeting, CT APPROVED suspending Line 61 of the Standing Rules “Presbytery shall hold three *stated* meetings each year.”, canceling the June Stated Presbytery meeting, and for WNC to plan a worship with emphasis on Juneteenth and possibly include a guest preacher for the June 20th collaborative worship service.
2. CT APPROVED the following loan certification from Presbyterian Investment and Loan Program to Covenant Presbyterian Church, Albuquerque. Stated Clerk Stephen Rhoades is authorized to sign as the Secretary of the Corporation of the Presbytery of Santa Fe.

#4a- Overture on Commending and Recommending the Guns to Gardens Movement

On Commending and Recommending the Guns to Gardens Movement to Prevent Gun Violence

Recommendation

The Presbytery of Santa Fe overtures the 225th General Assembly (2022) to:

1. Give thanks for, pray for and commend the congregations and organizations that have initiated the Guns to Gardens project as a way to responsibly dispose of unwanted firearms, turning them into garden tools rather than returning them to the gun market.
2. Recommend to the churches and presbyteries of the PCUSA that they learn about the Guns to Gardens project and prayerfully consider if it is a ministry to which they are called, as part of the PCUSA witness to prevent gun violence, save lives and provide healing for a nation traumatized by violence.
3. Urge the Presbyterian Peacemaking Program to add information about the Guns to Gardens program to its website list of Gun Violence Prevention Resources and encourage the Peacemaking Program and other communications and mission entities of the PCUSA to join in commending those congregations, presbyteries and synods that participate in the Guns to Gardens movement.

Rationale

The words above, *commend* and *recommend*, both contain the word **mend**. Mending is what Isaiah 2:4 envisions: “They shall beat their swords into plowshares.” Our nation has been traumatized by an epidemic of gun violence, with escalating suicide, family violence, police violence, murder, mass shootings and accidents. We need ways to prevent violence and mend, yet the federal government has taken no major steps to prevent gun violence in over a generation ---and many past steps have expired.

Continuously since the 1968 General Assembly, the Presbyterian family has called upon our officials for reasonable regulation of firearms to keep them away from those who may be a danger to themselves or others. The PCUSA has never called for the restriction of guns used in hunting or shooting sports.

In the absence of federal action, the Guns to Garden movement has arisen, training congregations to host safe surrender events for unwanted guns, to dismantle the guns with a chop saw or grinder, according to rules of the Bureau of Alcohol, Tobacco, Firearms and Explosives. There is no transfer of ownership, as the gun owner is present. Then the gun owner can donate the leftover parts to be forged into garden tools, jewelry or art. For safety and, in most cases, for insurance purposes, only unloaded guns can be accepted and no ammunition can be accepted.

Guns to Gardens provides a practical, pastoral and prophetic ministry:

1. Practical – With over 400 million guns in private hands, Guns to Gardens is a practical service that churches can provide to responsibly reduce the number of unwanted guns for their communities, without returning them to the gun market where they could do future harm. Examples: a grandfather who has hunting guns from years past and now has grandchildren visiting in the home; a family to whom the police returned a gun after it was used in a suicide or crime by their loved one; a household with someone who has a serious physical illness, depression or who is going through a crisis such as unemployment or divorce; an older person who has enjoyed owning guns but no longer feels that they can safely operate or handle them; a family with serious conflict or domestic violence; a parent who bought a gun during the pandemic but has determined that, with children in the home, a gun poses a greater danger than they had anticipated.

2. Pastoral – Guns hold memories, some good and some painful. The church is an appropriate host to accompany a gun donor while their gun is dismantled. They may appreciate a moment of prayer or silence, or simply someone to share their story with. The church is the place of pastoral healing. With the tenth year remembrance of the Sandy Hook School shooting on Dec. 14, 2022, congregations can join in Gun to Gardens around that date, as part of a national commemoration for action and healing.

3. Prophetic – For citizens to voluntarily rid their homes and communities of unwanted guns is to turn upside down the gun industry myth that we are safer with “guns everywhere.” For the church to facilitate this process is to show that God stands on the side of saving lives and preventing gun violence. By turning guns into garden tools, we demonstrate the biblical vision that God creates us to live in gardens, not battlefields. And, in the absence of action by our government to prevent gun violence, we take direct action to inspire elected officials to find their courage to also act to save lives.

For further information:

1. The copyright for “Guns to Gardens” is held by New Mexicans to Prevent Gun Violence. They have given free use of this title to congregations and other church bodies.
2. The founding organization for the Guns to Gardens movement is RAWtools.org, which is based in Colorado and led by Michael Martin, a former Mennonite pastor-turned-blacksmith. RAWtools provides logistical support and safe chop saw training. Their national network of blacksmiths forges leftover gun parts into garden tools.
3. The Gun Violence Prevention Ministry of the Presbyterian Peace Fellowship provides regular on-line training for congregations to learn “best practices” for Guns to Gardens safe surrender events, including congregational education, publicity, safety, volunteer roles, pastoral care and supporting a national network of congregations that offer repeated Guns to Gardens events in their communities. As of this writing, the Presbyterian Peace Fellowship (PPF) is working with congregations in Ohio, Georgia, California, Texas, Iowa, Utah, Maryland, Colorado, Illinois, North Carolina, Washington, New York, South Carolina, Kentucky and more. PPF is an independent faith-based organization, founded in

1944 to inspire and activate Presbyterians in the search for alternatives to violence, oppression and war.

#12a- Statement of Faith- The Rev. Judith Wellington

I believe in God, the creator and creating force of all that is, all that we see and all that we cannot see. The mysteries of the cosmos and the atom have their origins in God. And because God is creator and still creating, our existence on this material plane is part of “an unfolding,” “a coming into being” that we call life. We cannot fully comprehend all that God is, but we can trust that there is power, love, and meaning in life through divine love.

I believe in God’s saving, healing, and reconciling work through Jesus Christ who makes divine love known to us. In the second person of the Trinity, the God that humanity first feared as a mysterious, awesome power became known through the teachings and ministry of Jesus. Jesus manifested membership in God’s family beyond bloodlines, clan, or nation. Jesus turned human systems upside down and pointed humanity toward a loving and faithful God. For me, the Way of Jesus is the radical message of God’s good news for all creation. God’s story of salvation has fulfillment through the compassionate work of Jesus Christ.

We are empowered to live into our calling through the Holy Spirit, the very presence and energy of God, our companion, advocate, guide, and comforter. We nurture our relationship with God through spiritual disciplines that can be part of the rhythm of our lives. Not much has been said about the Spirit in the Reformed Tradition, but in the context of the Church and of my own indigenous cultures, I believe that the Holy Spirit is related to our lives both individually, collectively, and as we live with the rest of creation. The Spirit moves where it will to bring about transformation of hearts, minds, and systems. I believe that today as on the day of Pentecost, the Spirit makes God’s good news known in ways that are recognized and understood. The message being, we are loved by and belong to God; and we are invited to join God in blessing this world that God loves.

Called and empowered through the Holy Spirit, we find community through the Church. Here, we celebrate the sacraments of baptism and the Lord’s Supper, signs of God’s unfathomable grace and reminders to us that we belong to God. Although we find sanctuary, rest, and celebration when we gather, being the Church is not without risk. I believe God’s Spirit moves where we may not want to go and urges us to carry God’s love beyond our own circles. For the sake of those who are oppressed, neglected, abused, or in other ways without hope, I don’t believe the Church can take the easy way out by doing nothing. Jesus set the example, God’s Spirit empowers us, and God’s grace is sufficient for us to share divine love in all areas of our lives and ministries.

#12b- Statement of Faith- The Rev. R. Jeffrey Parker

(Words, words, words. The words we use are a very big deal, but only when they match up with the things we choose to do. This I have learned the hard way, but I am glad to know it now.)

Son of God, Son of Man, Pioneer and Perfector of my faith: I stand with Jesus of Nazareth, my friend and brother. It is not because of his power or authority. Nor is it because of the miracles of his birth and resurrection. Rather, it is his nature and character that spark my allegiance. “Blessed are the poor in spirit,” and those who mourn. “Blessed are the meek,” and those who are hungry and thirsty. “Blessed are the merciful,” and those who are pure in heart. “Blessed are the peacemakers,” and those who are persecuted for the sake of righteousness. Jesus is the Pioneer of my faith because he sets a new and unique course for each one of us and all of us. He is the Perfector of my faith because he alone has walked that path: he has completed the passage that he first charted.

The God of scripture – the living and ever-present Creator, the Risen Christ, and the Holy Spirit – drew near to Eve and Adam, to Abraham and Sarah, to Ruth, to Isaiah, to David and Jonathan...to Joseph and Mary, to Peter and Paul, to Lydia and Cornelius...and to centuries of witnesses since then. God has reached out to us before we were ever aware of it. This is the central story of the Bible, and that makes it the most valuable revelation we have, and absolutely central to my life and practice.

You are my sisters and brothers: I am a part of you. I am Presbyterian, guided by the wisdom of the **Book of Order** and **Book of Confessions**. When we genuinely meet our calling, so closely unified are we, that we are as one body with many parts. We become through the Spirit more than we could ever be on our own. This body proclaims the forgiveness of God to a beleaguered world. We bind up the brokenhearted. We advocate for the defenseless. We live a sacramental and devotional life, drawing on the vows of baptism and the regular sustenance of the Lord’s Table. When Christ’s church is at its best, God’s people become truly inspired: our lives exude peace, compassion, and hope.

Because I believe the above, I commit the short span of my days to helping others cultivate earnest lives of reflection, action, and prayer. Rooted in the history, polity, and mission of this branch of God’s great family tree, I am compelled by Christ to stand in allegiance with folk who are poor, and poor in spirit. The peacemakers. The hungry and thirsty. The merciful. I do so filled with joy, good humor, and determination.

#17- Administrative Commission to Gallup, Westminster

Report of the Administration Commission

For Westminster Presbyterian Church, Gallup

June 22, 2021, upon the resignation of Rev. Lorelei Kay, the Westminster Presbyterian Church (WPC) Session voted to ask the PoSF to appoint an Administrative Commission (AC) to accept original jurisdiction and become the Session for WPC. The AC was appointed with the following participants: Louis Knowles MWS, David Martinez MWS, June Lorenzo RE, Jeffery Smith RE, and Elizabeth Morgan RE.

Relying on the Commission on Ministry (COM) for assistance in finding pulpit supply, a team comprised of 4 pastors, Jerry Self MWS, Trey Hammond MWS, Patty Davison MWS and Randy Pence MWS, volunteered to provide rotating worship leadership until the end of October.

The AC, with the help of former WPC Session members, set priorities for tasks to be accomplished before a Mission Information Form (MIF) could be completed. The first task was to review the current financial status so that the congregation could make a decision regarding full time or part time status of a new pastor. The second task was to recruit and train volunteers to become the WPC Session.

A Congregational meeting was held October 3, 2021. After the financial report was given, the congregation voted to wait until the pledges for 2022 were in before determining what the pastoral search would be. Rev. Randy Pence volunteered to provide worship leadership until May 2022.

By January, it had been determined that pledging for 2022 was up 40% from 2021. Attendance on recent Sundays has been around 17 or 18. 23 were present on January 30. Commission member June Lorenzo visited Westminster on a Sunday in October and again on January 30. She reports that that in her estimation the situation had greatly improved by January and that an optimistic spirit prevailed at the annual meeting. The church has decided to hold services on Ash Wednesday and Maundy Thursday and possibly at sunrise on Easter.

Plans are progressing for a congregational survey to be sent out in order to determine the skills desired for a new pastor.

Two WPC members, Gerald Robertson and Heather Nasi, have volunteered to be Session members and plans are in place for their election, installation and training. It is the understanding of the Commission that Presbytery rules allow for a session of two with a voting moderator, in this case, Randy Pence.

The commission was made aware of discussions in the Committee on Ministry concerning the possibility of bringing a trained transitional minister to Gallup. The Commission is also aware of discussions that have gone on with one Phil Chandler, an individual with some ministerial training from Episcopalian sources and lay experience in the United Methodist Church. He is planning to join Westminster Gallup congregation and is interested in possibilities of becoming a commissioned lay pastor. The Commission has also become aware that a number of people who identify as Mennonite are now worshipping at Westminster but are not on the membership roles because of doctrinal

differences. The Commission will continue to monitor the situation and interact with congregational leaders at least through the spring when we expect the new session to be functioning in a healthy manner. We will encourage the new session to make decisions about the nature of pastoral leadership they will seek in the near future.

Among those collaborating in the process will be: Conrad Rocha, Stated Clerk/Executive Elder, Synod of the Southwest, Nancy Thomas, PW contact for Santa Fe Presbytery; Lola Blackwell, PW secretary for Santa Fe Presbytery; and Carol Marr, PW treasurer for the Synod of the Southwest.

NOVEMBER 20, 2021, ZOOM Cluster Meeting: Invitations were extended to all congregations in the Presbytery to give feedback about their PW involvement in a Zoom meeting. It was hosted by Susan Keil Smith, Moderator of the PW of the Synod of the Southwest. Susan Smith, Conrad Rocha, Nancy Thomas, Lola Blackwell, Anne Maglisceau and Margaret McTavish joined the meeting.

Margaret McTavish, First Taos, reported on an active PW in that congregation, including participation in the Bible Study, the Thank Offering, the Birthday Offering and a rummage sale which raised \$2000 for PW purposes.

Anne Maglisceau, Santa Fe First, asked for wider communication from the Presbytery and suggested that she would contact Westminster, Santa Fe, about a possible PW contact person. She reported limited activity at Santa Fe First at this time and, and their monthly lunches have been discontinued.

Susan Smith reported on two circles at First Albuquerque that are doing the 2021-22 Bible Study. Their Sunbonnet Shop continues to raise funds for mission, but it is in transition from items made by the group and friends to one that will utilize other sources for the items sold for proceeds to benefit various help agencies in the community. Susan noted that younger women prefer to engage in focused projects rather than meetings.

Lola Blackwell indicated that although there are not PW meetings currently occurring at Covenant, there is interest in future involvement. She suggested a Pen Pal type program. She hopes for a spring Gathering.

Conrad Rocha pointed out that PW has become “parochial.” Once the “conscience of the church at all levels” he senses that this is currently less true. He urges PW to bring justice issues to the fore and to be allies in behalf of them.

Nancy Thomas, who now lives in SC, has continued to serve as the contact for the PW to the Presbytery CT and the Synod PWCT, and she reports to their meetings. The Presbytery PWCT is currently inactive; however, Susan Smith serves as acting treasurer and Lola Blackwell serves as secretary. Lola

suggested a couple of names for possible future Presbytery level involvement. The last Presbytery PW Gathering occurred in February 2020.

Susan Smith noted that she has used the Presbytery newsletter, *Nuevo Noticias* as a means of several Zoom gatherings that have occurred in Arizona. The email list that is utilized to convey information needs to be updated. There is evidence that several congregations are continuing to meet and participate in the Bible Study; however there is not a reliable contact list. A follow-up to the cluster Zoom will be scheduled in February or March. (See above--March 3, 2022, Zoom scheduled)

Presbytery PW Horizons Bible Study by Zoom on the Third Monday of Each Month at 5:30:

Susan Smith continues to host and facilitate monthly discussions of the Bible study, *What My Grandmothers Taught Me: Learning from the Women in Matthew's Genealogy of Jesus*. The study has drawn participation from at least 12 different congregations since it was started in the fall of 2020. There were 11 participants on the January 17, 2022, study representing 7 congregations. The Truchas congregation currently has a strong group participating monthly.

Synod of the Southwest 2022 Triennium, October 27-30, 2022, Phoenix AZ: The Santa Fe Presbytery PW is committed to support Susan Smith, current moderator of the Synod of the Southwest PW, as she guides the planning for this important retreat gathering. Efforts will be made to engage women from Santa Fe Presbytery in making decisions to attend this key event and benefit from the inspiration and courage it provides in behalf of carrying out the purposes of Presbyterian Women.

#20b- Letter to the City of Albuquerque Regarding the Albuquerque Indian School Cemetery at 4-H Park

Dear Ms. Riley,

We as The Coordinating Team of the Presbytery of Santa Fe are writing in response to recent information regarding Albuquerque Indian Boarding School Cemetery at the 4-H Park. The Board of Missions of the Presbyterian Church (USA) was under contract with the United States government to run the Albuquerque Indian School from 1881-1885, which were its founding years.

Our denomination, the Presbyterian Church (U.S.A.) has 109 Native American congregations and the presbytery as part of the Synod of the Southwest (New Mexico and Arizona) through its Native American Ministries Committee has played a vital part in educating our presbytery about our history. We value the relationship we have with these siblings in Christ.

The national governing body, the General Assembly issued a formal apology for all the American Indian Residential Schools of which we were a part. (See enclosed document.) We own our responsibility in the sin of arrogance and racism that was explicit in these schools which were an exhibition of the Doctrine of Discovery. The apology is but a first step in the healing and reconciliation process.

The Coordinating Team, acting on behalf of the Presbytery of Santa Fe, wants to express our full support for the efforts of your commission and the city of Albuquerque to find the truth and bring healing for all the wrong that has been done. In particular we support efforts to know more about those buried in the cemetery at the 4-H park and whatever work is done to provide dignity and honor to those who are buried there and their families.

If we can be helpful with our historical records, or in other ways, please let us know. I would be glad to talk with you or members of the Commission. My contact information is at the bottom of this letter.

**Apology to Native Americans, Alaskan Natives and Native Hawaiians
222nd General Assembly (2016)
Presbyterian Church (U.S.A.)**

1. That the PC(USA) and its members apologize to United States citizens of Native American ancestry, both those within and beyond our denomination. We offer this apology especially to those who were and are part of “stolen generations” during the Indian-assimilation movement, namely former students of Indian boarding schools, their families, and their communities.² That the PC(USA) approve and issue the following words of apology:

We apologize for the pain and suffering that our church’s involvement in the Indian boarding school system has caused. We are aware of some of the damage that this cruel and ill-conceived system of assimilation has perpetrated on United States citizens of Native American ancestry. For this we are truly and most humbly sorry.

To those individuals who were physically, sexually, and emotionally abused as students of the Indian boarding schools in which the PC(USA)³ was involved, we offer you our most sincere apology. You did nothing wrong; you were and are the victims of evil acts that cannot under any circumstances be justified or excused.

We know that many within our church will still not understand why each of us must bear the scar, the blame for this horrendous period in U.S. history. But the truth is, we are the bearers of many blessings from our ancestors, and therefore, we must also bear their burdens.

Our burdens include dishonoring the depths of the struggles of Native American people and the richness of your gifts. Therefore, we confess to you that when our Presbyterian ancestors journeyed to this land within the last few centuries, we did not respect your own indigenous knowledges and epistemologies as valid.

In our zeal to tell you of the good news of Jesus Christ, our hearts and minds were closed to the value of your own epistemologies and lifeways. We did not understand the full extent of the Gospel of Christ! We should have affirmed the commonality between your spirituality and our understanding that God’s sovereignty extends with length from East to West, with breadth from North to South, with depth throughout the Earth, and with height throughout the Sky and Heavens.

Even worse, we arrogantly thought that Western European culture and cultural expressions were necessary parts of the Gospel of Christ. We imposed our civilization as a condition for your accepting the Gospel. We tried to make you be like us and, in so doing, we helped to diminish the Sacred Vision that made you who you are. Thus, we demonstrated that we did not fully understand the Gospel we were trying to preach.

We know that apology is only a first step in the larger hope of repentance and reconciliation. We seek the guidance of relationships with your people within and beyond

our church as we seek to identify and act on restorative practices and policies at the relational, communal, and national level.

We are in the midst of a long and painful journey as we reflect on the cries that we did not or would not hear, and how we have behaved as a church. As we travel this difficult road of repentance, reconciliation, and healing, we commit ourselves to work toward ensuring that we will never again use our power as a church to hurt others with our attitudes of racial and spiritual superiority.

We seek God's forgiveness, healing grace, and guidance as we take steps toward building mutually respectful, compassionate, and loving relationships with indigenous peoples. We also seek your forgiveness and hope you will walk together with us in the Spirit of Christ and partner with us as equals as we participate in God's redemption of the world so that our peoples may be blessed and God's creation healed.

Finally, we pray that you will hear the sincerity of these words and that you will witness the living out of our apology in our actions in the future.

2. That the Moderator of the PC(USA) share this apology with the ninety-five PC(USA) Native American congregations on behalf of the denomination. The means of sharing this apology shall be coordinated with the Presbyterian Mission Agency's Native American Congregational Support Office and with the PC(USA)'s Native American Consulting Committee (NACC).
3. That the Office of the General Assembly share this apology with the leadership of Native Nations in the United States. The means of sharing this apology shall be coordinated with the Presbyterian Mission Agency's Native American Congregational Support Office and with the PC(USA)'s Native American Consulting Committee (NACC).
4. That the General Assembly commend this apology to the entire PC(USA) in all its expressions for their use in the work of reconciliation among all peoples.

The Commission on Finance and Property held a meeting on December 16, 2021.

- Finance and Property has reviewed the investment portfolio with the financial advisor. The commission approved to not set aside the 3% amount for 2021 from the Presbytery's Spending Policy and to keep the funds invested.

FINANCE AND PROPERTY COMMISSION (F & P) ANNUAL REPORT

2021

Even amidst the continuing COVID-19 pandemic climate, one thing remained faithfully stable: the financial status of the Presbytery thanks to church stewardship. Even while facing real or potential financial uncertainty, the churches of the Presbytery continued to give to the Presbytery. Per capita giving was \$135,957 (an increase of \$4,000 over the 2020 per capita giving) and unified mission giving was \$176,735, which was in line with 2020. This total per capita and mission giving was in excess of \$312,000. This financial support from the churches is inspiring and appreciated.

The Presbytery continues to be blessed financially in the appreciation of its investment portfolio reflecting general stock market gains over 2021. Our outside managed investment portfolio rose to a year-end level of \$2,103,859.

As to the operating budget for the Presbytery, the total operating income was \$459,108 with total operating expenses of \$430,766 for a small buffer of almost

\$30,000 of income in excess of expenses. The primary change from 2020 was the increase in income from \$393,950 to \$459,108.

As for F & P, all of our meetings were on Zoom except for a retreat which was in-person, masked and distanced. I wish to gratefully thank the members of F & P who served during 2021: Carolyn Rhodes, Carol Cochran, Marty Bruner, Robert Busch and Judi Haines as well as our ex-officio members: Bill Belvin, Treasurer; and Presbytery staff, Chad Poole and Tiffany Lo-Finch. Each one of these members contributed their expertise, knowledge and viewpoint to the work of F & P.

Thank you, God for your faithfulness and the faithfulness of our churches within the Presbytery.

#100- Recommendation of Concurrence with Overtures to the 225th General Assembly

Report of the Overture Task Group
MWS Harry Eberts, RE Susan Keil Smith, and RE Conrad Rocha

This committee was established to review ascending overtures to the 225th General Assembly of the Presbyterian Church (U.S.A.).

Information on all ascending overtures may be found at pc-biz.org.

The list contains the full information of each overture: originating presbytery, proposed action, rationale, and a list of concurring presbyteries. This official list of overtures is updated as refinements to proposed actions are submitted and/or other presbyteries concur. *Note: this report was prepared for publication on February 15 and does not reflect actions submitted after February 14.*

The Task Group fulfilled its task by

1. Setting aside overtures that were referred to the 225th Assembly (2022) from the 224th Assembly (2020) and were considered by the Presbytery in February 2020.
2. Setting aside overtures that have concurrence and are regional, do not consider topic/issues pressing within the life of the Presbytery of Santa Fe, and all received after February 15 will not be presented.
3. Highlighting overtures that are in need of concurrence and are of topical interest for our presbytery will be considered for concurrence.
4. Acknowledging that the date of the meeting of the Presbytery of Santa Fe was after the deadline for concurrence of overtures involving changes in the constitution.
5. For information, many overtures found on the PC-Biz website were presented by committees and do not require concurrence from presbyteries,
6. Bringing a limited number of motions for concurrence will be introduced to the Presbytery; however, the presbytery may move concurrence on any motions (with the exception of those involving changes to the constitution).

For Action by the Presbytery:

That the Presbytery CONCUR with the following overtures to the 225th General Assembly:

- MC-01: On Recognizing Non-Chartered Fellowships as Churches to Promote Representation and Participation on National and Regional Committees and Councils
- POL- 11: On Establishing a Task Force to Explore the Theology and Practice of Ordination to Ordered Ministry for Ruling Elders
- POL-12: On Amending G-2.0504 Regarding Parish Associates
- RGJ-09: On Directing the Office of the General Assembly to Issue Apologies and Reparations for the Racist Closure of the Memorial Presbyterian Church, Juneau, Alaska

Synopsis of Overtures

MC-01: On Recognizing Non-Chartered Fellowships as Churches to Promote Representation and Participation on National and Regional Committees and Councils

Overtures to develop a means by which non-chartered fellowships can be counted as “churches” for the purpose of national reports and statistical data presentations. Non-chartered fellowships are often ministries relating to immigration, justice, and gospel work among peoples of diverse backgrounds yet unable to participate in discussions with presbyteries, synods, and other groups that are involved in the policy development and official recognition of churches within the denomination.

POL- 11: On Establishing a Task Force to Explore the Theology and Practice of Ordination to Ordered Ministry for Ruling Elders

Overtures the creation of a task force that will reflect the breadth of the PC(USA) and including those who identify as BIPOC (Black, Indigenous, and people of color), immigrant congregations, New Worshiping Communities, and middle governing body leadership. In particular, the rationale discusses the need for a path for emerging leaders for new worshipping communities that do not have sessions or ordained elders.

POL-12: On Amending G-2.0504 Regarding Parish Associates

This overture restores the office of parish associate to the Book of Order, which was removed from the Form of Government in July 2011. A parish associate is a minister who serves in some validated ministry other than the local parish, or is a member-at-large, or is retired, but who wishes to maintain a relationship with a particular church or churches in keeping with ordination to the ministry of Word and Sacrament.

RGJ-09: On Directing the Office of the General Assembly to Issue Apologies and Reparations for the Racist Closure of the Memorial Presbyterian Church, Juneau, Alaska

Overtures to meaningfully address the wounds inflicted on Alaska Natives, who were directly impacted by the sin of the unwarranted 1963 closure of a thriving, multiethnic, intercultural church; in keeping with the spirit to “confess complicity and repudiate the Doctrine of Discovery”.
