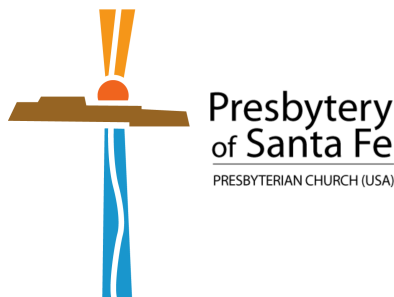
New Commissioner Orientation
